

**GENERAL ORDINANCE NO. 3, 2022
AS AMENDED**

AN ORDINANCE MODIFYING CERTAIN PROVISIONS OF THE TERRE HAUTE CITY CODE RELATED TO ONE-WAY STREET DESIGNATION AND SPEED LIMIT ON 27TH STREET FROM WILSON STREET TO OAK STREET.

IT IS HEREBY ORDAINED by the Common Council of the City of Terre Haute that the *Terre Haute City Code* shall be modified as follows:




SECTION 3. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.




