REORGANIZATION MEETING, THURSDAY, JANUARY 6, 2022

The City Council met in Reorganization Meeting on Thursday, January 6, 2022 at 5:45 PM in the City Hall Courtroom with Mr. Elliott presiding and Michelle L. Edwards in the City Clerk's desk.

Calling Of the Roll

PRESENT: Amy Auler, George Azar, Tammy Boland, Martha Crossen, Curtis DeBaun IV, O. Earl Elliott, Neil Garrison, Cheryl Loudermilk, Todd Nation

President Elliott opened the floor for nominations for City Council President. Councilperson Auler nominates Councilperson Cheryl Loudermilk for president. Council President Elliott announces nominations are closed and Councilperson Cheryl Loudermilk is president by acclamation.

President Loudermilk opened the floor for nominations for Vice-President. Councilperson Azar nominates Councilperson Neil Garrison for vice president. Council President Loudermilk announces nominations are closed and Councilperson Neil Garrison is vice president by acclamation.

Motion was made by Councilperson Crossen and seconded by Councilperson DeBaun to select Tribune the Newspaper of Record. Motion carried.

Council President Loudermilk announces the three candidates for appointments to Redevelopment Commission. Vote is to be by ballot. Paul Atterson receives five votes, Brian Conley receives eight votes and Karrum Nasser receives five votes. Brian Conley is selected for first position with a majority of the votes. Council President Loudermilk announces a second vote for the last appointment to the Redevelopment Commission between Paul Atterson and Karrum Nasser. Vote is to be by ballot. Paul Atterson receives four votes. Karrum Nasser receives five votes. Karrum Nasser is selection for the second position with a majority of the votes. Council President Loudermilk announces the candidate for appointment to the Police Merit Commission as William Toney. Candidate is approved by Council.

Council President Loudermilk announces the candidate for appointment to the Animal Control Commission as Maggie Wheeler. Candidate is approved by Council.

Council President Loudermilk announces the candidates for the two appointments to the Information Technology Advisory Board as Stephen Chenoweth and Chris Garner. The candidates are approved by the Council. Council President Loudermilk announces the selection of the appointments to the Human Relation Commission will occur in February.

Council President Loudermilk announces the appointment of Councilperson Cheryl Loudermilk to the E-9-1-1 Board, of Councilperson Tammy Boland to the Area Plan Commission, of Councilperson Todd Nation to Downtown Terre Haute board, of Councilperson Neil Garrison to the Riverscape Committee, of Councilperson O. Earl Elliott to the Transportation Committee and of Councilperson George Azar to the Solid Waste Management Board. Councilperson Azar makes a motion to approve those appointments and Councilperson DeBaun seconds the motion. Motion carries.

Council President Loudermilk announces the City Council Standing Committee appointments.

Motion was made by Councilperson Azar and seconded by Councilperson Garrison that the meeting be adjourned. Motion carried.
