GENERAL ORDINANCE NO. 15, 2013

AN ORDINANCE AMENDING CHAPTER 8, TRAFFIC CONTROL PROVISIONS OF THE TERRE HAUTE CITY CODE.

WHEREAS, the City Engineer’s Office is in the process of reviewing specific portions of the City’s Traffic Code and has identified changes in conditions that warrant amendments to the City Code; and

WHEREAS, a review of the flashing intersection control beacons schedule reveals that changes to traffic control regulations (i.e. insertion of four-way stop intersections, school closures, etc.) warrant the removal of certain flashing intersection control beacons; and

WHEREAS, due to the closure of Chauncey Rose Middle School, certain “school speed zones” are no longer appropriate in the area and must be removed from the traffic code; and

WHEREAS, due to prior annexations, street name changes, emergency traffic diversions off of I-70, and two (2) roadways that were accepted from the State of Indiana, certain amendments must be made to the City’s truck route schedule; and

THEREFORE, BE IT ORDAINED by the Common Council for the City of Terre Haute that:

SECTION 1. *Terre Haute City Code*, Chapter 8, Section 8-14, Flashing Intersection Control Beacons – Schedule DD, is hereby amended by deletion of the stricken text as follows:


