In May of 2016 the City received a Special LOIT Distribution from the State of Indiana that required a portion of the distribution to be spent on roads. We allotted that amount to be spent on the City's portion of the Margaret Avenue Overpass in Fund #0257, the LOIT Special Distribution Fund.

We thought the match portion for the overpass would be paid in 2016 therefore nothing was budgeted for 2017. The City paid our match portion in February 2017 so the payment was made from the EDIT Fund budget. Attached is an appropriation request to repay the EDIT Fund for the amount of the Special LOIT Distribution that was allotted for the overpass.
