Request to Appropriate Funds in the Wastewater Utility Fund #0620

I am requesting an appropriation of \$1,607,554.17 in the Wastewater Utility Fund for the BAN (Bond Anticipation Note) that the City received from Vigo County. The Wastewater Utility Fund provides the funding for all Bond/BAN repayments. The money must first be appropriated as a transfer from the Wastewater Utility Fund #0620 to the County BAN Fund #0624 from which all the principal and interest payments are made. This is the first appropriation in a two step process.

The second appropriation required is from the County BAN Fund #0624 which is broken down by principal and interest. In essence, the funding is transferred from the Wastewater Utility into the BAN Fund for payment. Payment is then made from the BAN Fund.

The City is only required to make semi-annual interest payments but the Administration decided, along with City Council support, to make early principal payments.

The total principal and interest payments will be \$1,747,554.17 for 2018. This consists of \$1,500,000 in principal and \$247,554.17 in interest. \$140,000 was previously appropriated in the Wastewater Utility Fund #0620 through the budget process therefore only \$1,607,554.17 is required (\$1,747,554.17 - \$140,000) for this appropriation.
